# Iowa Lesson Package Options

## Package A: 16 hours of online training (including bias prevention and de-escalation) comprised of:

- at least 4 hours of legal update training, based on recent cases from the Iowa Supreme Court, the Iowa Court of Appeals, the U.S. Supreme Court, and the 8th Circuit Court of Appeals;
- 1 hour of legal update training based on recent Iowa legislation;
- 1 hour of mental health training per 501 IAC 8.1(4)(b)\*;
- 4 hours of bias prevention and de-escalation training per Iowa Code § 80B.11G & 501 IAC 8.1(6)\*;
- other applicable training.

**Package A is \$160 per officer per year.** PLS does not charge a package fee for reserve officers so long as the number of reserves does not exceed the number of paid lesson takers. Beginning with February 1, 2025 subscriptions, PLS will charge a \$2 per user service fee for each user, whether fulltime or reserve. PLS bias prevention and de-escalation training content may be repeated from prior years.

## Package B: 12 hours of online training (not including bias prevention and de-escalation) comprised of:

- at least 4 hours of legal update training, based on recent cases from the Iowa Supreme Court, the Iowa Court of Appeals, the U.S. Supreme Court, and the 8th Circuit Court of Appeals;
- 1 hour of legal update training based on recent Iowa legislation;
- 1 hour of mental health training per 501 IAC 8.1(4)(b)\*;
- other applicable training.

**This package does not include bias prevention and de-escalation training.**

**Package B is \$120 per officer per year.** PLS does not charge a package fee for reserve officers so long as the number of reserves does not exceed the number of paid lesson takers. Beginning with February 1, 2025 subscriptions, PLS will charge a \$2 per user service fee for each user, whether fulltime or reserve. PLS bias prevention and de-escalation training content may be repeated from prior years.
